Certifications and Features of the Air Queen Nanofiber Mask

- FDA 510(K) approved mask:
 - o "A 510(K) is a premarket submission made to the FDA to demonstrate the device to be marketed is as safe, effective and substantially equivalent to a legally marketed device (section 513(i)(A) FD&C Act) that is not subject to premarket approval. Submitters must compare their device to similar legally marketed devices and support their substantial equivalence claims."
- Made in Korea and approved for medical use.
- High breathability due to proprietary nanofiber technology.
- Strong moisture control with 0.1μm filtration efficiency.
- The Air Queen does not have NIOSH approval due to its ear loop design, but fulfils NIOSH requirements in other areas.
- Independent research performed by Nelson Labs confirms the Air Queen mask provides particle protection and air flow beyond the level afforded by N95 rated products.
 - "Wearers of the Air Queen mask were found to have lower heart rates, lower micro-environment and skin surface temperatures than subjects who wore standard N95 masks while performing similar tasks."
